Time to Shine is The Arts Center's annual non-juried entry, members-only Art Show and Sale, offering award categories and a judge (to be announced).

FEE: \$15.00 = 1 piece, \$40.00 = 3 pieces; limit is 3. All works accepted. **All work must be for sale.**

HAND DELIVER WORK: Monday, January 6, 2020, from 1 to 4 PM to Sacramento Fine Arts Center (The Art Center), 5330-B Gibbons Drive, Carmichael, CA 95608. Arrangements may be made to delivery your work earlier by calling or emailing.

ELIGIBILITY: Your 2020 membership must be paid before entering this show. You may pay your membership at the time of entry to the show. All media is welcome, only original work not previously shown at the Art Center. No copies of published work, no class or workshop work, crafts, giclée's, videos, film, or work produced by commercial printing processes. Original photography is okay.

SPECIFICATIONS: Submit work completed within the last two years. Work with glass must have rigid gallery-style framing. Work exceeding 29" x 35" must use plastic. No unfinished canvas edges, protruding nails, staples, or saw-tooth hangers. Use braided wire or durable plastic line and flat brackets instead of screw eyes to attach hanging wire. Tape wire ends. Diptychs and Triptychs may be entered as one work. Sculptures weighing over 50 pounds are to be installed and removed by the artists. Installations must meet fire and safety codes; free-standing work must be stable and safe for viewing. Awards given will be solely at the Judge's discretion. Complete the entry form below, and the small forms available at receiving to be attached to your work.

LIABILITY: The Art Center will be diligent in the care of all artwork, but it is not responsible for loss or damage that might occur. Insurance is the responsibility of each artist.

COMMISSION: The Art Center will keep commissions of 30% of member's work sold, and 10% of youth member's work sold.

REMOVING WORK: Accepted and sold work must remain for the duration of the show. Sold artwork will be released to the seller on Sunday, January 26, 2020, owners of unsold work may pickup their work at the same time between 5 and 6 PM.

STORAGE FEE: Owners of work left one week following the close of show will be charged \$5.00 per day, per work. Work left 30 days following close of show becomes property of the Art Center.

AGREEMENT: I have read, understand, and agree to abide by all exhibit rules. I waive any and all claims against The Art Center and individuals associated with this exhibition. Submitted art is my original work and has never shown at The Art Center. I give my permission to the Art Center to reproduce my work for publicity. I will remove my artwork on January 27, 2020 between 5 and 6 PM.
